The best way to help the economy is to spend money. So say the financial experts with all the fancy degrees from all those prestigious universities. You don't ever hear those experts extolling the virtues of self reliance. That's because the more self reliant you are the less money you spend.

A lot of people view self reliance as an outdated virtue, old fashioned to the point of being outright historical. You would grow and preserve your own vegetables and then you wouldn't have to spend so much on food. You would sew your own clothes, quilt your own bed covers and fix your own cars out under the shade tree.

But what about the modern entrepreneur who uses his laptop and the internet to do business and keep records and do taxes instead of hiring a secretary and bookkeeper? The secretary and bookkeeper he does not hire do not have paychecks to spend that will contribute to the economy. What about those home schoolers, who collectively reduce the number of teachers who find jobs and receive paychecks to spend? How about all those texters and emailers who have reduced the number of postal employees who spend their checks into the economy?

The thing about self reliance is that it does not show up in the figures put out by all those lettered experts. The number of jobs may be down because all those extra teachers and postal employees are not getting paid. But the population itself enjoying better finances because of the self reliance afforded by modern technology. Less work and less pay is not such a bad thing if it does not mean less goods and services, but does mean less taxes.

The industrial revolution brought about a mass-production mentality in which people stopped being independent individuals and locked themselves into roles as part of the larger society. They performed their limited functions in the economy and paid for others to perform the functions they no longer did themselves. This system failed us miserably.

Now technology has enabled us to restore self reliance to our lives, side by side with participation in a mass-production based system. We can move back and forth between them as benefits ourselves.

Don't be fooled by those gloomy numbers put out by the experts. They are based on corporate ways of measuring things. The experts, if they want to retain any credibility at all, need to come up with new points of measurement that accurately reflect the way things work now.

Meanwhile don't let the chicken-little media scare you. Get right in there and live. The more self reliance you add to your life the less you will depend on the corporations and the powers that be and the more they will appreciate your business and your labor.

Court dismisses rev. Hale's case for freedom

Not even requiring the government to respond to his allegations, and wasting no time on little nuances like the requirements of the Constitution of the United States and the fact that he is being imprisoned for 40 years without any violation of a criminal statute, the district court in Denver, Colorado has, on June 16th, promptly dismissed Reverend Matt Hale's latest case for freedom. The case is Hale v. Berkebile, No. 14-cv-1233 and the decision can be found at docket number 18. Hale will be filing a motion to reconsider and should that fail, an appeal to the Tenth Circuit Court of Appeals.

Reverend Hale is the former leader of the pro-White and anti-Jewish WCOTC. Until his arrest in 2003, he was America's most well-known and effective public advocate for that cause, appearing numerous times on television shows such as "The Today Show" and "Politically Incorrect" and being featured in magazines such as GA, Spin, and others.

A 1998 graduate of Southern Illinois University School of Law, he was convicted in 2004 on politically-motivated charges of having solicited the murder of Chicago federal judge Joan Lefkow, during a pending trademark case, even though there is no evidence that any such solicitation occurred.

Despite repeated attempts to regain his rightful freedom ever since, that freedom has continued to be denied by the courts, usually by corrupt judges who have outright lied about the facts of his case in order to keep him imprisoned.

Hale has filed misconduct complaints against some of the judges in question but since those complaints are ruled upon by their colleagues, those complaints, too, have been denied. From his prison cell in solitary confinement at the infamous "Supermax" prison in Florence, Colorado, Reverend Hale has this to say about the summary dismissal of his new case for freedom:

"The eleven page decision was written by Judge Lewis T. Babcock, who held that the Denver district court lacks statutory jurisdiction to hear the merits of my case for freedom but who also opined that I had to produce new evidence in order to prove my innocence even though I am already innocent as a matter of statutory law. I disagree strongly with both contentions and believe that due to the faulty reasoning and misunderstanding of the law that lie behind them, I have good cause to file a Rule 59(e) motion to reconsider and that's what I'm going to do. Should that motion fail, I will be appealing to the Tenth Circuit Court of appeals. I am glad though that Judge Babcock's opinion is free of the kind of ideological hatred that I was faced with by the judges in the Chicago area. Rather, I simply disagree with his generally anti-prisoner view of the law and intend to vindicate a more fair and just viewpoint in future legal proceedings. People need to understand that extreme bias is built into the rotten legal system that we have the misfortune to live under and that true justice is sadly beside the point,"

First, what is circumcision?

Wikipedia describes it as following;

"Male circumcision is the surgical removal of some or all of the foreskin (prepuce) from the penis. Early depictions of circumcision are found in cave paintings and Ancient Egyptian tombs, though some pictures are open to interpretation. Religious male circumcision is considered a commandment from God in Judaism. In Islam, though not mentioned in the Qur'an, male circumcision is widely practiced and often considered to be sunnah. It is also customary in some Christian churches in Africa. Estimates by the World Health Organization (WHO) suggest that 30 percent of males worldwide are circumcised, of whom 68 percent are Muslim. The prevalence of circumcision varies mostly with religious affiliation, and sometimes culture. The timing of circumcision similarly varies, though it is commonly practiced between birth and the early twenties. Circumcision is used therapeutically, as one of the treatment options for balanitis xerotica obliterans, phimosis, balanitis, posthitis, balanoposthitis and recurring urinary tract infections. In addition, non-therapeutic circumcisions are commonly performed for social, cultural, religious, or prophylactic reasons. Summaries of the views of professional associations of physicians include that none currently recommend routine circumcision, and most recommend neither universal circumcision nor its prohibition. "

So essentially circumcision is something foreign to our people. It is something that probably never even occurred to us as a people before we encountered the jews. Evidence suggests to me that we did not begin to circumcise our boys in America until women started to have their babies in hospitals. Considering the fact that these hospitals were funded and ran by Jews it makes logical sense that they would push their degenerate theories of baby mutilation on us. It is interesting to note that when a jew is circumcised an adult male will



literally suck the child's penis to 'clean' it. Circumcision is for Jews part of their so-called covenant with their god. Circumcision did not begin as medical procedure but as a foreign and tribal ritual of our racial enemies.

There are many mainstream arguments for circumcision. They include but are not limited to: An almost 50% reduction in HIV transmission, reduction of STD transmission in general, reduces the amount of "thrush" i.e. yeast infections in women, decreased UTI's, it is cleaner and sons will look like their Fathers. The arguments against circumcision are as follows: it is a cruel, unnecessary and painful procedure, it is removing a highly sensitive area thereby providing the male with less pleasure during sexual stimulation, when conducted during infancy it removes personal choice regarding a man's right to decide for himself what is done with his body. Circumcision has many health risks which outweigh the benefits such as infection, hemorrhage, surgical mishap, and death. Not to mention it is disfiguring.



The studies concerning HIV/AIDS were conducted in Africa which already has the highest rates of HIV/AIDS in the world. Much evidence suggests that the results of these studies were fabricated. Even if they were not one could argue that more likely than not the very presence of the medical community in a third world country could reduce the transmission rates through education alone. Not to mention the fact that safer sex is always promoted in the medical community wherever it goes. Regardless, as Creators we value monogamy and partnership above random and meaningless sexual encounters. Any sociological studies conducted in third world countries have very little bearing or benefit to us because we are so radically different from other races both physically and culturally and morally.



Whenever you try to persuade people about the evils of circumcision there always seems to be those who rise to defend it. There are excellent and irrefutable reasons why circumcisions should not be performed. The defenders of circumcision engage in peculiar, contrived, tangential, and ad hominem arguments. They seek to divert attention from the best arguments against circumcision because

they can't muster rational arguments against them. Here are arguments against circumcision that are ignored by those who defend the practice.

1) Circumcising infants exposes them to the risk of death, the amputation of the penis, serious infection, massive hemorrhaging, brain damage, the mangling of the penis and the destruction of the proper functioning of the penis. These risks are well known and are described in medical textbooks. Circumcision is a medically unnecessary procedure with very serious risks. There is no sane reason to expose infants to such risks.

2) Circumcision causes the victim excruciating pain which persists long after the circumcision is performed. Most babies pass out from the procedure. Babies have had heart attacks and died because the pain and shock is so great.

3) Circumcision reduces feeling by over 40%. The victim will feel less than 60% of what they would have had they not been circumcised. The truth of this is attested to by men who have been circumcised as adults.

4) The foreskin serves to protect the glans and to provide a gliding action during intercourse. Circumcision destroys these functions.

One should also note that when a girls clitoris is hacked off either in whole or in part there is a world wide outcry declaring it "genital mutilation". When the same is done to a male it is called a 'medical procedure'. Cutting away a part of a males genitalia should be viewed in the same way. Many men who were circumcised as adults describe noticing a definite decrease in sensitivity. How is it morally ok for us as parents to make this decision for our sons when it is clearly a deeply personal decision regarding an intimate and private part of their anatomy? Nature saw fit to put the foreskin there. It is there for a reason. Leave it alone.

INTERVIEW: FINNISH RESISTANCE MOVEMENT

This interview was made by TCM Croatia.

- You are somehow 'younger' section of Nordic Resistance Movement. How did idea come to make this step? Was there any other similar WN organization in Finland before?

Hello! Thank you for this interview!

Actually the Finnish Resistance Movement (FRM) is the second oldest part of the Nordic Resistance Movement (NRM). It all began in Sweden in the late 1990's with the formation of the Swedish Resistance Movement (SRM). SRM has its roots for example in the urban guerrilla organization called Vitt Ariskt Motstånd (VAM) or the White Aryan Resistance in English. Some time after finishing his prison sentence for the acts allegedly committed by the VAM, Klas Lund went on to found the SRM. Although the NRM works in a very different way than the VAM did back in the day, we still have a lot of respect towards e.g. The Aryan Resistance Movement (better known as "The Order") headed by Robert Mathews. It will ultimately take a hard struggle in order to save the future for our Race.



FRM was founded by Henrik Holappa in 2008 and since then we've seen the formations of Norwegian Resistance Movement and the Danish Resistance Movement. The idea to form FRM came actually from Richard Scutari, an incarcerated member of the Aryan Resistance Movement. He had been for years in letter correspondence with Henrik Holappa. Scutari knew people from the SRM and urged Holappa to contact them. Since then the cooperation between Finland and Sweden has been strong.



Because of the laws dictated by the Soviet Union, White radicalism was illegal after the WWII until the collapse of Communism in Russia. FRM is the first National Socialist organization here since the WWII. Thus we've had to build everything from scratch. Fortunately we've got many good advices from our friends in the Nordic countries and also from countries such as Germany and Italy.



- Do you have active members only in major cities and do you make protests only in large cities?



At the moment we're most active in the big Finnish cities such as Helsinki, Turku, Tampere, Oulu, Jyväskylä and Pori. We also have a lot of members in smaller towns, but larger activist groups exist in cities at the moment. We work hard in order to spread to every town and city eventually. Unfortunately people in small towns are quite hesitant to risk their reputation by being openly pro-White.

Usually they offer us silent support and information on e.g. local immigration policy. In large cities it's easier to be a radical as one has more privacy and like-minded people around. We've had public protests and different kinds of activities in many different places. It's important to take the Racial message to areas where noone has dared to talk about it before us.

- It is well known what kind of situation is in Sweden with immigrants. Is Finland in same problems? Controlled media only shows a small part of those problems regarding your country.

Sweden has a longer and more liberal history when it comes to immigration from non-White countries. The situation in big Swedish cities is a lot more lethal than in Finland with actual Race riots already taking place. That's one reason why Sweden has also a lot larger pro-White/National Socialist movement: As the Africans procreate and get more and more violent, the common Swede will see through the lies of Race-mixing mass media. It's interesting, that the most powerful mass media company in the North is owned by a Jewish family named Bonnier.





It comes as no surprise that they promote as liberal immigration policy as it gets.

Both in Finland and Sweden the immigrants have brought with them random violence and brutal sexual crimes. Mass rapes didn't exist in the North before the arrival of Africans and people from the Middle East. Another reason why more and more common people have become disillusioned with immigration is the economy. Blacks receive large sums of money from the government but aren't interested in working. Of course we in the Resistance Movement aren't really that interested in whether blacks work or don't; they are Racial aliens and ought to be deported for that reason alone.

- You make public protest very often, plant stickers and posters. Are Finnish laws tolerant to give free speech about racial problems?

Yes, our activist groups distribute local propaganda every week. Besides that we organize larger protests, activities and publicity stunts on a monthly basis. Our activists also like to travel to other countries and support local White movements. We feel that our message must be seen all the time on the streets so that common Finns don't forget about the Racial reality that the mass media tries to shun down.



You can get a sentence for "incitement for Racial hatred" quite easily in Finland. That's why we've been very careful with our words. We talk very radically and very openly about issues such as Race, Zionism and even violence. However, we do it in a way that does not incriminate us. I'm sure the Finnish laws will become more intolerant towards National Socialist speech in the future, but so far we haven't got any sentences for our texts or propaganda. It's not so much about what you say but rather how you say it.



- Some of your actions end up in violence. There were some reports of stabbing (controlled media). Can you tell us more how those conflicts start?

We've been involved in some fights started by the political opposition (usually reds). Our policy is to deal



with people in a peaceful manner if it's possible. However, there are people who would like to break our Movement down by the means of violence. We accept no disrespectful or aggressive gestures by our political enemies. As you mentioned, there was a big fight and a stabbing in January 2013, when a large group of reds tried to assault our activists. According

to the police, the main suspect is still on the run. As National Socialists we must stand our ground and never give in when confronted. In Sweden and Norway the situation is much the same. Because of determined action in such situations, we are able to take our message openly to the streets without the opposition interrupting us.

- Do your members support any political party in Finland?

No, there are no Finnish parties worthy of support. The mass media abroad calls the so called True Finns party "nationalist", which is a big lie. The True Finns party supports the global banking system and the rogue state called "Israel". They have homosexuals and immigrants from different Racial backgrounds in their ranks and they are openly "anti-racist". That party is a tool to channel the common people's anti-immigration sentiments in a "safe" way from the political elite's point of view. The whole political system is corrupt. Just today we learned that the biggest funder of our current Prime Minister is a Zionist Jew called Chaim Zabludowicz! We encourage the Finnish people to act on the streets right now instead of relying on corrupt politicians. The ballots may or may not be a part of the political struggle at some point but right now it's more important to work on the streets.

- What are your relations with Swedes? We know that in the past Finland was under Swedish rule for very long time. Are there any tensions on nationalist base?

The relationship between National Socialist Swedes and Finns is a very warm one. We share a common goal, common values and common Racial heritage. Historical conflicts are not of our concern. National Socialism is all about white cooperation in order to secure our common Racial future. If there are tensions in the national movement outside



NRM, the tensions are still very marginal. Usually they only manifest in drunken Internet messages by antisocial low-lives. Every sane individual understands that the nationalist Swedes of today are not responsible for the politics of past centuries.



- Same question regarding Russians.

This is a more complicated issue. Many Finns still equate the Russians with the Communists and the Soviet Union. Not many even know that the Communist revolution of Russia was orchestrated by Jews rather than Russians. The current development in Ukraine has concerned

many common Finns, and the Zionist politicians want to abuse the current climate and drive Finland to Nato. Many of us have been in contact with good Russian nationalists who oppose imperialism and have great respect for the Finns. However, the issue of Russian nationalism isn't that simple. Although we understand many Finns' concerns regarding Russia, we first and foremost oppose the European Union, United States, Nato and all the other western powers that are the true source of current liberal decay.

- On your website you gave open support to Greek party Golden Dawn. Do you have any relations with other organizations or parties outside Finland?



We've been in touch with many organizations and individuals around the world. However, the concrete cooperation is done within the framework of the Nordic Resistance Movement. The success of Greek Golden Dawn has of course inspired nationalists in the North and also convinced many people that Europe still hasn't lost all of its hope.

- Do you participate in any protests in other countries? Poland and Russia are relatively close.

As an organization we have participated in demonstrations in Sweden and Germany. As individuals our activists have also attended many other demonstrations in different parts of Europe. We've followed the development in Poland and Russia with great interest but haven't taken part to activism in those countries as an organization.

- Did any of your members died because of the attack of leftist scum?

There have been no political casualties in Finland since the WWII as far as I know.

- There's a lot of professionally made propaganda material (stickers, leaflets, videos) on your website. Do you make it on your own or do you use help from experts outside your



movement?

Thank you for the commendation! Most of our propaganda has been designed in Finland by our activists, but some times the members of the Nordic Resistance Movement share propaganda designs. We feel it's important that the Movement is quite self-sufficient and able to produce propaganda that precisely fits local needs and situation.



- Finnish Air Forces has a official flag with swastika. Can you tell us more about. It is almost unbelievable to see that symbol in Europe in official use. Was there any problems?

The Swastika is a traditional symbol in the Finnish culture. After the WWII the Allied Comission ordered many of the Swastikas removed for obvious reasons. But as you said, the Swastika is still used on part of the Air Forces' symbolism. I guess Air Foces can be thankful that we don't have as delusional a Jewish lobby in Finland as e.g. in Germany (laughs)!

- Is there any other activities among members beside protests and any propaganda. Sports, gatherings, friendships...?



Yes, especially sports, lectures and social gatherings are important ways to enhance the group spirit and to develop our activists as Resistance fighters. Our activists are also very much into hiking and survivalism in the wilderness. We intend to build an organization that covers the whole spectrum of life from political activism to sports, family, culture and of course Resistance. A good social climate is demanded if we want to live through the turbulent times of the forthcoming revolutionary struggle as an organization.



- Your fellow Finn Kai Murros wrote in his short book that revolutionaries need to hear and help ordinary people. Do you follow those words, helping ordinary people in any way?

That statement is very true and it's clearly seen in the successful work that Golden Dawn is doing in Greece. However radical, the Resistance will always build its support and survival on popularity and the acceptance by the common people. There can be no revolution without strong acts of social justice. There have been some local actions of this kind in Finland, but we will talk more of them in public in the future.

- Are ordinary people in Finland aware of racial problems with immigrants? What is general opinion about open borders?

I answered partly to this question in the beginning of the interview. Most of the common people understand that non-White immigration will only cause crime and poverty. The political establishment, the mass media, the police and the school system do all they can to suppress these views and make people feel ashamed of their "racism". The majority of the population wants less immigration but few are ready to protest about the issue in public. Petty fear is the greatest enemy of the White race.



- We know that women are very important part in all aspects of society. Do you have also female members?

We do have female members and we feel it's extremely important to enhance women's role in the National Socialist milieu in the future. National Socialism is not a "male club" but a movement to unify all the healthy White people.

- Nikko Puhaka is one of the most known WN in professional Martial Arts fights. Do you have any members that are also active in MMA sports?

Our activists are regularly training self-defense. In Finland the trend is the same as in other European countries: Well-known radical nationalists are kicked out from established Martial Arts courses for their political beliefs. That's why we've formed small sports communities where nationalists teach each other these skills. It's quite disgusting that the mainstream Martial Arts instructors are actually denying self-conscious White youth the right to defend



themselves effectively. It's an act of Racial treason, really.

- Do your members have any religious views? Is this important when someone wants to join?



As an organization we don't have a specific religious affiliation. We welcome all honourable National Socialist to our ranks regardless of their religion as long as they are ready to fight for the survival of the White Race. Religion can be a good motivator to fight and sacrifice for the greater good, as many White martyrs have had a strong faith.

- Are you familiar with activities of Creativity Movement and works of Ben Klassen? Do you know about Matt Hale sentence for 40 years in supermax prison?

Many Finnish National Socialists are well-read and know about the work of both Klassen and Hale. Both of them have inspired people to take a radical stand for the survival of the White Race. Hale's sentence only shows how afraid the establishment is of strong White militancy.

Klassen's Teachings:

Parasites and Predators - The Majority in Nature's Scheme



The Eternal Laws of Nature. The Jewish bible foolishly promises us the "coming millenium" when a universal peace will descend upon the world, and "the lion will sleep with the lamb," presumably without the lion eating the lamb for breakfast. To realize how utterly ridiculous such fantasies are in the light of Nature and reality, all we have to do is make a cursory study of how the great majority of all living creatures are either predators or parasites, or both. This they have been for millions of years, and will forever remain so, or starve to death. The lion and the lamb peacefully sleeping together might be a great philosophy for the lamb, but a very sick and suicidal philosophy for the lion. Should the lion be foolish enough to embrace it, he and his species would soon starve to death and become extinct.

Predators. Most species of fish, birds, insects, reptiles and mammals are predatory. In short, they hunt and kill other species of life and consume them as their daily food. Fish eat tadpoles, shrimp, minnows, and in general, the larger fish eat the smaller fish. This is the Law of Nature and the ecological "Chain of Life" in the sea, starting from the smallest live creature in the food chain, the plankton. The plankton, which derives its food from the minerals of the ocean water, is the great exception, but then there has to be a starting point. From there on out it is mostly fish eat fish, and on up the ladder. Birds eat insects, worms and other live creatures different from themselves. However, hawks, eagles, falcons also hunt and kill other birds and consume them as food.

Others form Prey. The animal kingdom is largely divided into Carnivora and Herbivora. The carnivores are flesh eaters, and the herbivores eat herbs, grasses, vegetables, or in general, plant food. Some like the bear, are omnivores, a mixture, eating on both sides of the trough. There are also the frugivores and the graminivores, as I have mentioned. Those like the wolf, coyote, lion, tiger, and many others whose mainstay is meat, must hunt and kill to feed themselves and their offspring. Otherwise they would starve. They are called "predators" and their victims are the "prey." Without prey, the predators would starve to death.

Survival the Only Morality. Nature does not handicap the predators with any moral "hang ups." It tells the coyote to freely catch the rabbit and bring him home to dinner, and if he doesn't, he and his species will starve and become extinct. The coyote is not bothered with pangs of conscience about "killing one of god's creatures." Nature places supreme emphasis



on survival. It places the ultimate penalty on those too sluggish in the struggle for survival. That ultimate penalty is extinction.

Man a Predator. Now we come to our own species ó mankind. Here we find that man, like the bear, is a mixture, carnivorous and herbivorous ó predator and producer. In a previous chapter we have already designated him as a frugivora. In the case of some nigger tribes in Africa, he is even a cannibal and eats his fellow man. Whereas from earliest times man relied on hunting and killing game for food, in modern times the civilized White Race raises, grows, and in one way or another, takes a hand in producing most of what he consumes, whether it be beef or pork, or fruits, grains or vegetables. Nevertheless man is a true predator, and undoubtedly the most successful predatory mammal alive.

Some Species of Mankind Parasitic. A certain segment of the human race is not only predatory, but intensely parasitic. Since we are mainly concerned about the White Race and since our race suffers much greater damage from human parasites than other predators, it is parasitology in particular we want to examine more closely.

PARASITISM

Parasite Defined. Parasitism can be described as a mode of life in which an organism of one kind (the parasite) lives within, or upon, an organism of another kind (the host) with the primary objective of obtaining food and sustenance from the host.

Whereas with the Carnivora the relationship is between predator and prey, in parasitology the relationship is between "parasite" and "host," the latter being a benevolent term indeed, since the host suffers the parasite not because it wants to, but because it can't get rid of the parasite.

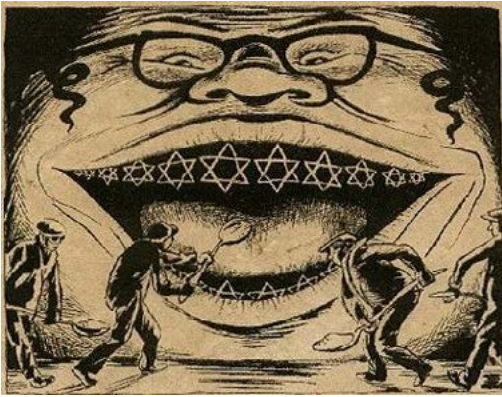


Parasite Completely Dependent on Host. Parasites differ from predators in the fact that whereas predators usually kill in order to devour their prey, the ideal relationship from a parasite's point of view is to feed upon a host from which it can indefinitely suck its blood and life juices without killing the host. The best situation of all is, if possible, to keep draining the life juices from the host without inflicting significant damage to the victim. After all, if the host dies, the parasite dies, since it cannot live without the host. In any case, the parasite has to be able to attach itself to the host, either on the surface, like lice, fleas, ticks and mosquitoes, or internally, like tapeworm, hookworm, amoebae, trichina and many

others, including viruses, germs and bacteria.

Parasites extremely numerous. Besides the microscopic parasites such as germs, which we cannot see, the most familiar to us are those of the insect world. Undoubtedly such insects as lice, fleas, bedbugs, mosquitoes, tse-tse flies, have been feasting on and annoying man and animal from time immemorial. But fish, birds and even insects, have their parasites, too. Since, at present at least, the most dangerous threat to the future survival of the White Race is a human parasite on its back that the White Race does not seem to be able to shake, let us study the life style of a few typical parasites in Nature.

The Argulus a Perfect Parasite. The Argulus is a fish louse. It is a parasite that attaches itself to the skin surface of fish. It is well equipped for its business. Although not a good swimmer, it can swim freely under water, using its legs as flippers. Once it lights on the body of a fish, its legs are marvelously designed to become grappling hooks and it attaches itself firmly to the body of its victim, which could be any one of a number of fish, such as a carp or a sticklefish. Once it has itself attached, the host fish seems helpless to shake it off. The next piece of ingenious equipment the Argulus brings into play is a long sharp hypodermic needle. This it slides under the scale of the victim fish and into the body tissue. From thereon out the Argulus has a direct pipeline to the life juices of the victim, and can feed at will, with very little effort on its part.

Parasites can kill. Often a host (victim) is infested with a number of Argulus on its body surface, sucking away at its vital juices. In such a case the fish becomes sluggish, and as it weakens, it dies. The Argulus have then lost their succulent host as a source, and must abandon it and make the effort to find another. Such is not an ideal relationship from the parasite's point of view, since it has "killed the goose that laid the golden egg", and thereby at least temporarily destroyed its source.

The Trichina. Whereas the Argulus is an external parasite (ectoparasite) the trichina is an internal parasite (endoparasite). The trichina is a small spiral worm, too small to be seen by the naked eye. The trichina also lives in animals, especially pigs and eating the

meat of infected pigs is the main cause of human trichinosis, a disease widely distributed in various backward parts of the world.

Raw pork biggest source. The disease is mainly contracted by humans by eating raw or improperly cooked pork containing cysts of the larvae. The cysts are digested in the stomach, releasing the larvae. They migrate to the intestine where they mature. The females are viviparous (the young are born alive, no eggs) and may produce as many as 1,800 progeny in 6 weeks. The young parasites then find their way into the lymphatic system and are distributed throughout the body. They eventually settle in the muscles, especially the diaphragm, chest and tongue muscles. After a period of several months the host body deposits calcium around the encysted worms, trying to isolate them. The worms also often invade the heart muscles, causing myocarditis. It is estimated that five worms for every gram of body weight can cause death.



Still Prevalent. According to a 1948 Encyclopedia I have, 20 million people in the United States were affected by it. Due to better treatment of pork (thoroughly cooking) and some modern medication, the disease has now been virtually eliminated in the United States but still flourishes in many backward countries.

A Part of Nature. I could go on and illustrate the modus operandi of any number of other parasites. There are thousands of varieties. But I think the two cited above suffice to illustrate how parasites operate and how they prey on their unwilling hosts. Humanity (as well as other species) still suffers from the miserable burden of mosquitos, fleas, lice, bedbugs, worms, ticks and dozens of other parasites, and undoubtedly has throughout its existence. However, it has survived them all, and through modern technology is even gaining some measure of control over them.

The Human Parasite Most Deadly. But there is one species of human parasite that the intelligent White Race has not yet been able to either control or shake off. That human parasite is the International Jew. Because of the White Man's failure to properly defend himself against this parasite, like the story of the fish with too many Argulus, it is killing the White Race.
