GOOD LUCK, JEW LIEBERMAN!

While this might be a surprise to some, Al Whore's choice of Jew Lieberman as his running mate for the presidency of the Jewish Occupational Government is a not cause for mourning, but rather, for celebration. PM Hale Decides Not to Appeal ISU Case Ruling

As indicated in last month's *Struggle*, the Appellate Court for the 4th District decided to affirm the trial court's decision to dismiss the suit which PM Hale had brought against Illinois State University in January of last year--a suit which stemmed from ISU reneging on an invitation to PM Hale to speak at its campus. Since the appeal process would be lengthy, since there is no guarantee that the Illinois Supreme Court would even hear the case (the same "court" that refused to even hear his law license case), and since there are other, more important battles to be fought and won at this time, PM Hale has decided not to appeal this case. No Word Yet On Decision In Trademark Case

The hearing in the phony trademark case against the Church for August 22 (as indicated in last month's issue of *The Struggle*) was canceled in early August, and PM Hale was notified that Judge Plunkett would be making his ruling on the various matters involved in it by mail instead. At the time of this writing, no ruling has been made. On both sides of the Atlantic Ocean, White people are struggling to remain White while facing the growing tide of the mud races' invasion. 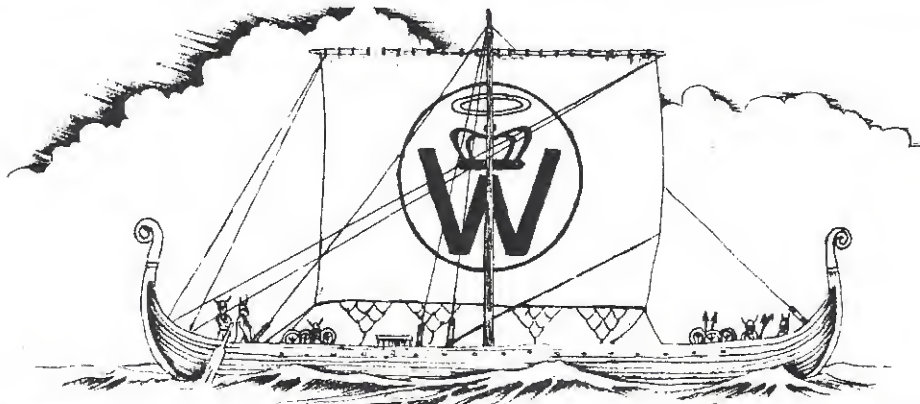

Proposed cable show by white supremacist group angers NAACP

NEW HAVEN (AP) — Plans for a new public access cable television show by a white supremacist group in the New Haven area have touched off some protests.

Roland Joni Young, president of the NAACP's Greater New Haven branch, said Thursday the promotional materials and theme of the broadcast by the World Church of the Creator are hate-filled.

"I'm going to call on the good residents of these areas to get this taken off the air," Young said.

The group believes that minorities are inferior and supports a racial holy war.

"We have a lot of people who agree with us, and we're hoping the show will increase that number," the Rev. Matt Hale, head of the Peoria, Ill.-based group said.

The program, "White Revolution," will be aired beginning Monday in Branford, North Branford, East Haven, Guilford, Madison, North Branford, North Haven and Wallingford.

"We're happy to have the show run in Joe Lieberman's home state. We're going to be exposing Jewish influence in the government and the media, etc., on future shows," Hale said.

AT&T Cable Services spokeswoman Dee Finley said the company is bound by law to allow the show to be aired on local cable access.

"The beauty of television is that no one is forced to watch, and so those who would choose to censor someone because of their political views aren't making the choice not to watch it for themselves, they're trying to make the choice for other people," Grabarz said.

In 1999, Cablevision of Connecticut, which broadcasts in Fairfield County, lost a three-year battle to forbid Jerry "Jerry Jay" McClellan from airing a show that previously featured nudity and humor that some found offensive. Just last month, the FBI investigated alleged threats made against U.S. Sen. Joseph I. Lieberman by Rabbi Mordechai Friedman on a New York public access cable TV show. The show remained on the air.

"Viewers make the ultimate decision whether they watch or not. The public access provider can't be the one editorializing or censoring, bottom line, as much as we personally may abhor the content," Finley said.

Roland Joni Young, president of the Greater New Haven branch of the NAACP, said she believes in free speech but feels communities have a "moral obligation" to reject the World Church program. "People do have the ability to say whether this is something they want piped into their homes," she said. If nothing else, people can turn off their TVs or change the channel, she added.

Young viewed a tape of the program Friday and said it sends a "disturbing message." The organization will send a copy of the tape to its legal counsel to review whether the program crosses the line in advocating violence, she said.

Finley considers public access channels to be an "electronic Town Green," but Comcast Cablevision Vice President of Connecticut Systems Tom Coughlin, whose company broadcasts in New Haven, believes the channels are a video

allow the show to be aired on local cable access.

Cable operators have the final decision on what airs on channels they own, but not on public access channels due to First Amendment guidelines from the Federal Communications Commission.

The group's tape is to air at various times through the end of August, with a second tape planned for mid-September.

"We're happy to have the show run in Joe Lieberman's home state. We're going to be exposing Jewish influence in the government and the media, etc., on future shows," said Hale, who has never specifically espoused violence.

Organizations that monitor hate groups consider World Church of the Creator a fringe group, but it gained notoriety last year when one-time member Benjamin Smith went on a shooting spree in Illinois against Asians, blacks and Jews. Smith killed two people and wounded eight before taking his own life.

World Church of the Creator members were also tied to racially motivated beatings and robberies in Florida in 1997 and 1998.

Roland Joni Young, president of the NAACP's Greater New Haven branch, said the promotional materials and theme of the broadcast are hate-filled.

"I'm going to call on the good residents of these towns to get this taken off the air," Young said.

"It's antithetical to a multicultural

society. It goes against everything America stands for. We're not going to tolerate it."

Jorge Perez, D-5, president of New Haven's Board of Aldermen, said it's "sad" to see such activity in the year 2000.

"This shows the struggle is not over. We have to be as vigilant as we've ever been," Perez said.

Videotapes of the show are being distributed for broadcast by an unidentified Wallingford resident. Hale declined to reveal the resident's identity.

The group's Web site lists contact points around the world and nation including Wallingford and Fairfield.

On Aug. 5, Wallingford resident Brian Davis, 21, identified himself as a World Church of the Creator member after being arrested in a motor vehicle stop in Cambridge, N.Y.

Cambridge Police Chief George Bell said a search of the vehicle revealed several illegal weapons, including a 12-gauge shotgun, 22-caliber rifle and a 22-caliber revolver stolen in Bridgeport in 1995. Ammunition for "assault weapons" such as M-16 and Ruger-14 rifles was also found.

Also apprehended was Bruce Silvermail, of Plymouth, who Bell said had been previously arrested on "hate crime" type charges in Connecticut. Bell said Davis had no prior arrests.

Cable company required to air show on public access

The controversy over next week's broadcast debut in several Greater New Haven communities of a program by the white supremacist group World Church of the Creator is the latest round in an ongoing battle over what should be aired on cable television public access channels.

"It will always be an issue we grapple with," said AT&T Cable Services spokeswoman Dee Finley, whose company is required by federal and state laws to air the program despite finding the content offensive.

World Church of the Creator leader the Rev. Matt Hale, preaches that minorities are inferior. And while he said he does not advocate violence, he supports the concept of a racial holy war.

Hale's show, "White Revolution," will air on AT&T Cable next week in Branford, East Haven, Guilford, Madison, North Branford, North Haven and Wallingford.

"A cable operator shall not exercise any editorial control over any channel designated for public educational or governmental use except for programming which contains obscenity, indecency or nudity," states section 611 of the federal Cable Act.

The federal law specifically refers to public educational or government channels. It was upheld in a 1989 challenge when city and cable company officials in Kansas City, Mo., unsuccessfully tried to forbid the Missouri Knights of the Ku Klux Klan from airing a program.

White Supremacist Show Will Air In Seven Towns

A white supremacist group will soon be spreading its self-proclaimed racist message in seven southern Connecticut towns through public access cable television. And the cable company says it can do nothing about it.

"We don't exercise editorial control," said Arthur Donkin, a member of the Cable Advisory Council of South Central Connecticut, which oversees cable in the seven towns where the programs are scheduled to be shown. "We don't review tapes. We don't know their contents, nor should we."

The programs, titled "White Revolution," are protected by the First Amendment's right to free speech. As long as they are not pornographic or infringe on copyright laws, they must be aired, said Donkin.

The programs attempt to teach children "to be as racist as possible," said Matt Hale, the 29-year-old leader of the World Church of the Creator in East Peoria, Ill. The program is scheduled to air next week on Channel 21 in Branford, North Branford, Guilford, Madison, East Haven, North Haven and Wallingford.

Hale said the programs were submitted

to AT&T Cable Services by Wallingford resident Brian P. Davis, 21, who was arrested this month in upstate New York after being stopped by police while driving a car loaded with ammunition and three weapons.

Hale said the tapes will "tell the truth" about Benjamin Smith, who went on a three-day shooting rampage in Indiana and Illinois last year.

Smith, 21, killed two men and wounded nine others before killing himself. He targeted blacks, Jews and Asians as his victims. Hale said Smith was his friend, and he is attempting to set the record straight about him.

Public access television is governed by the Federal Communications Commission, which prohibits obscenity and indecency. In Connecticut, cable television is regulated by the state Department of Public Utility Control.

The board of directors of local

cable stations may pass their own rules for accepting programs for broadcast. After a religious sect in Fillmore, N.Y., submitted a videotape purporting to expose "the agents of the anti-Christ" to Guilford public access, officials decided shows that are not produced locally must at least have a local sponsor.

And in 1986, Jerry McClellan of Bridgeport, known to viewers as "Jerry Jer," was tossed off public access television after a stripper appeared nude on his show. McClellan got his program back last year after agreeing to several stipulations, among them that he must submit a program tape to the cable station, Cablevision, seven days in advance.

Lisa Scalls, president of the Connecticut NAACP chapter, said the White Revolution programs might be protected by free speech laws, but she is urging viewers to tune them out.

"We are suggesting to parents and reasonable people that these programs contain messages that we would not want our children to watch," Scalls said Friday.

But in fact, exposing white youths to a white supremacist culture is the main goal of the programs, said Hale, whose title is Pontifex Maximus, or high priest, of his organization.

"The airing of White Revolution is part of a coordinated effort to win more of our White Brothers and Sisters to our great Cause," Hale wrote in a press release announcing that his programs would be broadcast in Connecticut.

"In particular, I hope that many White children will watch the show so that they can learn and accept the Truth before having their minds polluted with anti-white concepts," Hale wrote.

Hale suggested that the motivation for Smith's unprovoked murders was the refusal by Illinois authorities to allow Hale to practice law. Hale calls himself a "doctor of law" and said he is considering applying for a law license in Connecticut.

Davis was arrested Aug. 5 in upstate New York after several hundred rounds of ammunition, a loaded shotgun, a semiautomatic rifle and a .22-caliber pistol were found in the trunk of a car he was driving in Cambridge, N.Y. Davis could not be reached for comment Friday.

Police said they also found literature in the car linking Davis and

passenger Bruce F. Silvernail, 28, of Plymouth, to the World Church of the Creator.

Silvernail and Davis told police they were headed into the region for target practice. A federal judge ordered Silvernail held without bail until a preliminary hearing scheduled for Monday. Davis posted bail and was freed after being charged with drinking while driving and two counts of having a loaded firearm in a car.

Hale could not say how many "racist loyalists" he has in Wallingford. But he said his followers there are attempting to spread the organization's message for "a whiter and brighter world" through a door-to-door campaign and by politician-style appearances outside supermarkets.

He described the White Revolution programs as offering viewers the white race perspective. "The show is a pro-white show," Hale said.

"We believe our cause is noble and just. We don't accept the characterization that we are hate-mongers."

He said his goal is to have all of the 23 television programs he produced and hosts shown in Connecticut.

Montana group doesn't want Hale

EAST PEORIA — Avowed white supremacist Matt Hale might move to Montana in the hopes of practicing law there.

information, and I like what I see," he said Thursday.

But a human-rights group in Montana says it doesn't want the 29-year-old head of the anti-Semitic and racist World Church of the Creator to relocate there.

"We don't say he doesn't have a right to live here. We are saying we hope he doesn't live here," said Ken Toole, program director of the Montana Human Rights Network.

To that end, Toole and other network members are circulating a petition to organize support against Hale and his group.

Last year, Hale was denied a law license by an Illinois panel that judges prospective lawyers on their "character and fitness." He appealed to the U.S. Supreme Court, which refused to hear his case earlier this summer, effectively killing any chance Hale had of obtaining a law license in Illinois.

Faced with that, Hale has been exploring his options, including moving to another state in the hopes he could practice law there.

"Montana approves your character before you sit for the bar exam, so I wouldn't have to take the bar exam if they have a problem with me," he said. In Illinois, a prospective attorney first takes the bar and then has his character evaluated.

Hale has confirmed he's

looking at four or five state but he declined to name the others, saying he doesn't want to stir up any negative publicity that could hurt his chances.

He called the Human Rights Network a "bunch of hypocrites" for opposing his quest for a license.

"They call themselves the Human Rights Network and yet, they are obviously interested in stifling my rights to practice my profession," Hale said.

Toole said his group will not call upon the Montana Bar Association to deny Hale a license, but took exception to Hale's use of the First Amendment, saying there are many regulated professions.

"I am not aware of any where in the Constitution that says you have a right to be an attorney," he said.

Rather, Toole said, the group is exercising its right to say it doesn't want Hale in Montana.

"These guys (the World Church) have a right to the opinion, but we think that a people have a right to express their opinion, and ours is that we don't want him here," Toole said.

The World Church holds a convention each year in Montana. In the past, Toole said about two dozen people have shown up to the gathering. Hale said his group has about two dozen members in the Missoula area, but he declined to give a membership estimate for the state.

No distributing pamphlets at mall

An associate and I were recently exercising our First Amendment right to distribute church literature in the parking lot of Chapel Hill Mall when our rights were heinously trampled upon by the police.

We were detained for criminal trespassing and littering and were thrown in jail for about 10 hours.

Obviously, these are bogus charges. When did the law change to require permission to go to a local mall? What did a zealous crusade for one's religion where holy literature was disseminated to the masses become littering?

Our rights as citizens are crumbling away. How much oppression and mistreatment can a people endure before the snap and violence erupts?

An Odious Cable Show

The First Amendment to the U.S. Constitution protects not only noncontroversial speech but also speech most people would find odious.

A perfect example is the TV program "White Revolution" being broadcast this week by AT&T Cable Services on a public-access channel in seven towns in the New Haven area. The World Church of the Creator, which bills itself as "a pro-white religious organization," sponsors the avowedly racist show.

The church's spokesman, Matt Hale of East Peoria, Ill., calls himself the "leader of the most controversial racist and anti-Semitic organization in America." He says the group's TV series is designed to teach white youths "to be as racist as possible."

Let anyone think this is idle talk not to be taken seriously, a member of the group was convicted of

first-degree murder in the slaying of an African American Gulf War veteran in Florida. Another member, Benjamin Smith, went on a three-day shooting rampage last year, targeting blacks, Jews and Asians. He killed two people and wounded nine others before killing himself.

If Mr. Hale uses the TV broadcast only to spout his hateful views, then his speech is protected by the Constitution. The cable provider is correct in not trying to censor his speech. The best response for viewers is simply to change the channel and tune him out.

If, however, Mr. Hale crosses the line and tries to incite people to violence, he will be subject to arrest and prosecution.

One of democracy's strengths is that it can allow the expression of a wide range of views — even the warped ranting of someone like Mr. Hale.
